**1) CourtCall Founder Shares Story**

>>Mark Wapnick '72 believes that some of his best ideas have come out of frustrating situations. In 1995, the real estate and business attorney came up with the idea for CourtCall as he sat in traffic during a 40-mile trip back from court. His appearance had lasted fewer than five minutes, but his entire trip cost him several hours of driving time and hundreds of dollars for his client.

"I thought there had to be a better way," said Wapnick, who shared his story with the USC Law community during the March 2 installment of the "Conversations with the Dean" speaker series, hosted by Dean Robert K. Rasmussen. "I wondered why couldn't we have done this by telephone? It was only a two-minute appearance."

>>Two years ago, Ian Maher '11 was teaching biology at a high school in the USC neighborhood. Today, as president of Street Law, he visits high school classrooms with fellow law students to teach young people about the law--and soon he'll be joined by attorneys from Sheppard Mullin.

Street Law, the venerable youth-oriented law education program, has announced a partnership with Sheppard Mullin to create opportunities for attorney involvement in the USC community. Leading Sheppard Mullin's participation in USC's Street Law is associate Olivier Theard '01, a founding member of his firm's Diversity and Inclusion Attorney Network. The network aims to match attorneys with existing community and education programs in Los Angeles and in other cities where the firm has offices.

### 3} Students Head to Border to Provide Aid

---

>>At 1:30 on a chilly winter morning, 13 USC Law students stood on the United States-Mexico border with dozens of farm workers awaiting the arrival of transportation to the fields nearby. It was an atypical way to wrap up their winter break, but the students were there with purpose. They volunteered two days of their time to help California Rural Legal Assistance survey farm workers about their working conditions in the fields. For the third year in a row, the law school's [Legal Aid Alternative Breaks \(LAAB\)](#) group has teamed with CRLA to assist residents and workers in low-income rural communities. Joined by Acting Director of Public Services Malissa Barnwell-Scott, the students traveled to El Centro, where CRLA staff trained them in labor and employment law and taught them how to complete the comprehensive working-condition surveys.

>>A subcommittee of the Fair Political Practices Commission (FPPC) - the state's independent watchdog of politics and campaigns - will meet at USC Law on March 24, 2010, to discuss the current trends of paid political activity on the Internet, email and social networking sites.

The subcommittee will address several questions, including whether new rules are needed to regulate paid political activity on the Internet, in email and on social networking sites. The panel will also look at who is behind electronic messages campaigning for and against candidates and ballot measures in California.

USC Law Professor and Commissioner Elizabeth Garrett is co-chairing the hearing with Commissioner Timothy Hodson of California State University, Sacramento.

## 6} Reflecting on the Supreme Court's Midterm

---

>>David Savage, the Los Angeles Times' Supreme Court reporter and one of the most respected legal journalists in Washington, D.C, spoke recently at USC Law about what lies ahead for the Court as it enters the second half of its term.

During his 24-year tenure covering the Supreme Court, Savage has written extensively about many of the most controversial issues facing the court this term, including abortion rights, prison sentencing, immigration, affirmative action in schools and campaign finance.

"The justices are very intelligent and thoughtful but they have totally different views on just about everything," Savage said. "They are clearly divided ideologically on the key issues."

## 8} Parole Hearings Chief Speaks to Students

>>Martin Hoshino, executive officer of the Board of Parole Hearings, spoke to a small group of students and faculty Feb. 4. Hoshino, who was appointed by Gov. Arnold Schwarzenegger in January 2008, gave an overview of the correctional system and discussed the challenges facing the Board of Parole Hearings. He spoke to a group of mostly students who are enrolled in the USC Law Post-Conviction Justice Project.

The clinic, co-directed by Profs. Michael Brennan and Heidi Rummel, represents inmates at the California Institution for Women, located in Corona, Calif. Students enrolled in the year-long clinic represent clients in parole hearings and legal challenges to denials of parole in state and federal courts.
