>> At law firms, companies and other organizations last spring, USC Law alumni rallied their Trojan colleagues to participate in the Law Firm Challenge by making gifts of any size to the law school. By June 30, when the annual competition ended, roughly 70 percent of alumni from 50 competing firms and other organizations had made a gift; 17 firms reached the overall goal of 100 percent alumni participation.

### 3} USC Law Seeks Alumni Mentors

---

>> USC Law's Career Services Office (CSO) is looking for volunteers for its Alumni Mentor Program for second- and third-year law students. In the tradition of the law school's annual 1L Mentor Lunch, this volunteer opportunity will allow 2Ls and 3Ls to develop meaningful mentor relationships with USC Law alumni working in a practice area and employer-setting in line with their career goals.

The Alumni Mentor Program is part of a larger student program the CSO is offering called the Intensive Career Management Program (ICMP). The ICMP provides students with the opportunity to work closely with a career counselor in the CSO in a more structured manner than the traditional career counseling model. The goal of the program is to motivate students to develop a more active job search strategy.

### 4} New Business, Entertainment Programs are Big Draw

>> Beginning this semester, students have the opportunity to add a little more business savvy to their legal repertoire. USC Law has formally launched its certificate programs in both business and entertainment law. While the two programs intend to educate students about the skills necessary for their prospective careers, each are individually tailored to create comprehensive awareness about specific industry practices.

Although only a few weeks old, the programs already have drawn a significant number of students: 44 J.D. and 41 LL.M. students have registered for the business law certificate program while 37 J.D. and 17 LL.M. students will pursue a certificate in entertainment law.

### 5} Class of 2013 Arrives on Campus

---

>> Gone are the dog days of summer – for USC Law’s Class of 2013, it’s time for school. An Aug. 17 convocation kicked off a busy week of orientation activities for USC Law’s latest class of J.D. students. At the ceremony, the Honorable Nora M. Manella ’75 administered the oath officially beginning the legal careers of the Class of 2013.

The 221-member class of 2013 represents the best and brightest from a record pool of 6,587 applicants. The median LSAT score of the incoming USC Law class (167) remained constant compared to last year, but the 25th and 75th percentile scores both increased this year, to 166 and 169, respectively. The average undergraduate GPA of this year’s class also rose, from 3.60 to 3.64.

## **6} G&IP Class Largest to Date**

---

>> One of the hallmarks of a USC Law education is the incredible diversity of the student body. And for proof of that diversity, look no further than the school’s newest, and largest ever, class of international scholars, who have come to Los Angeles from 21 nations spanning four continents.

In 2010-11, 127 Master of Laws (LL.M.) students, along with four Master of Comparative Law (M.C.L.) students, two visiting VIP students, two exchange students from the University of Hong Kong and one exchange student from the London School of Economics will study at USC Law. Sixty-eight of the incoming LL.M. students got a head start on their USC Law experience by completing the school’s Summer Law & English (SLE) program.

## **8} USC Law Prof. Underwrites New Institute**

---

>> \$500,000. No strings attached. What would you do with it?

For Elyn Saks, recipient of a 2009 MacArthur Foundation “genius grant,” the answer was simple. Of course, before arriving at that answer, Saks, like anyone in her position, had some fleeting thoughts about burning through the money herself.

“I could go to the French Riviera and live drinking wine and eating wonderful cheese for a few years,” she once thought to herself. “But I wanted to do something useful.”

So instead of indulging in summer soirées on the Mediterranean, Saks, the Orrin B. Evans Professor of Law, Psychology, and Psychiatry and the Behavioral Sciences, used some of the money to found a center on mental health policy that she hopes will become the best of its kind.

And so the Saks Institute for Mental Health Law, Policy, and Ethics was born. The Saks Institute will spotlight one important mental health issue per academic year. For 2010-11, it will focus its attention on the use of mechanical restraints in psychiatric hospitals.

>> When Brian Gillogly set out to make his documentary, “Accidental Icon: The Real Gidget Story,” which screened on Aug. 14 at the Egyptian Theater in Hollywood, he thought his greatest challenge would be to convince Kathy Zuckerman – the real woman behind Gidget – to cooperate.

That was far from the case. Gillogly actually faced his highest hurdle over copyright issues for the “Gidget” television shows and movies. He couldn’t afford the licensing fees to use the footage, and believed his project was doomed.

That’s when Gillogly solicited advice from USC Law’s Intellectual Property and Technology Clinic and its director, USC Law Prof. Jack Lerner.
